Please be sure all toys are at least 3 inches in diameter (this is important because smaller toys can go down our drains). We do not allow bones of any type (including Nylabones) due to size restrictions. **All items being left must be labeled with your pets' first and last name.** Any items that become soiled will be cleaned/sanitized in a commercial grade system. **MSAH will not be responsible for any damages to or loss of personal items left with your pet.**

- **Should a pet become ill during their stay, we will make every reasonable effort to contact the owner and advise them of the situation. Until that time, MSAH will be authorized to give the necessary care or treatment for the pet at the owner's expense.**
- **All pets must be free of internal and external parasites. Any pets found to have fleas, ticks, intestinal parasites or fungal infections will be treated immediately at the owner's expense.**
- **All pets must be up to date on required vaccines. If pets are found to be overdue or if vaccines cannot be verified by phone or fax, they will be given upon admittance for boarding.**
- **There is always a 2 day minimum board rate and a 4 day minimum board rate for holidays. All rates start on the day the pet is admitted for boarding. Animals picked up prior to Noon will not be charged for that day of boarding.**
- **Boarding pets can only be picked up from our main hospital (101 Metairie Road) during the following times:
Monday—Friday 8 am—5:30 pm Saturday & Sunday—8 am—5:00 pm**
